We are approaching a significant milestone in 2022-23. The RISDA-Bangladesh turned 30 years old in 2023. 





4.0 RISDA PROGRAMS

4.1 MICROFINANCE

The Microfinance program is a crucial element of the overall development package offered by RISDA to individuals who fall within the categories of ultra-poor, landless and marginal farmers, as well as small farmers. Microfinance is widely recognized as a crucial financial service that plays a vital role in facilitating the economic empowerment of those living in poverty. This is achieved by several means, such as the establishment of groups, the generation of savings, and the provision of loans. Additionally, microfinance institutions also engage in activities such as document management, training programs, and awareness campaigns pertaining to important topics like health, education, human rights, and climate change resilience. The primary investment sectors encompass crop farming, vegetable production, poultry and animal rearing, fish culture, handicrafts, transportation, and other non-farm businesses. The Microfinance program has a certain degree of autonomy and has achieved





SUCCESS HISTORY OF MICROFINANCE

Anjali revives through dairy Project

Anjali's Dairy- A traditional microfinance project in RISDA-Bangladesh. Anjali Rani (25) wife of Mr. Indroject Ghoas (35) lives in Akrain Bazar village at Birulia union, Savar Upazila of

Dhaka district. Since October 2020 she enrolled in the traditional microfinance programme in the Meghna Mohila Shomittee, her ID 1106. Throughout IGA and borrower survey she was selected as cow rearer. Initially she had taken BDT 49,000 (USD\$ 490) as initial loan to buy a cow afterward she expanded her cow rearing business within 03 years she has get the amount BDT 1000,000 (USD\$1000) in more two times to expansion her business and as result her farm is full of 18 cattle where 04 no of milk



cows that`s produce 60 kg milk /day, price in BDT 4800 (USD\$480) and there are 14 no of bulls for beef fattening which all together price in BDT 4,200,000 (USD\$ 4,2000). She is paying her weekly installments regularly as total of monthly income around in BDT130,000(USD\$1300). She feels happy with her two school going kids and told "I am very much great full to RISDA-Bangladesh for help me to standing my feel"

LOW-COST HOUSING

The project in Faridpur district is being implemented by RISDA-Bangladesh with the financial and technical assistance provided by Bangladesh Grahayan Thabil of Bangladesh Bank. The aim of this initiative is to provide financial assistance in the form of loans for the construction of dwellings. The target beneficiaries are individuals with low income, including homeless persons, particularly focusing on women workers and slum residents who are facing severe housing challenges. These challenges are exacerbated by natural disasters such as cyclones, floods, and river erosion. In the current year, RISDA-Bangladesh has successfully completed the construction of 24 houses, amounting to a total investment of Tk. 16,80,000. This funding was provided by Grahayan Thabil of Bangladesh Bank. As of June 2023, a cumulative total of 70 with funding TK 3,362,437 dwellings have been created RISDA-Bangladesh.



4.2 SKILLS DEVELOPMENT PROGRAMME



RISDA-Bangladesh has been facilitating socio-economic upliftment marginalized individuals through its Skills Development Training program. This training program encompasses several skills such as dressmaking and tailoring, block-batik printing, screen printing, and tie-dye techniques, among others. The project being implemented by RISDA Bangladesh is receiving financial and technical support from the Bangladesh Foundation (BNFE), Vulnerable

Women Benefit (VWB), Hazardous Child Labor Mitigation. During the reporting period, a group of 2600 female individuals were provided with training in the field of tailoring. Furthermore, as of June 2023, a cumulative total of 3,506 participants received training in various skills development programs.

VOCATIONAL (TVET) TRAINING



RISDA-Bangladesh has developed vocational training institutes with the aim of providing training in various trades to individuals from the unskilled, less literate, and economically disadvantaged communities. The training program encompasses many skills sets such as clothing making, needlework, electrical and house wiring, plumbing and pipe fitting, as well as refrigeration and air conditioning, welding, Caregiver, Fashion Garments, Mason, Rod-binding, Graphic

design & freelancing, digital Marketing & free lancing, Web design & development, Basic IT operations, Motorcycle servicing, Light Vehicle Driving LMF etc. The institution possesses a permanent campus located in Birulia, Savar & Mirpur, Dhaka, Saltha, Faridpur & Cox`s Bazar. Additionally, there are outreach centers located in Pirojpur, Rajapur, Asulia, Kutubdia, Rajshahi, Rangpur Bhaluka, Mymensingh. RISDA is currently operating skills training in 6 Divisions, 11 Districts, 28 Upazilla where 39 occupations and 97 level of NTVQF as per





Bangladesh Technical Education (BTEB) and National Skills Development Authorities (NSDA) certification course has offered for youth skills Development Training & Job placement, up to reporting date the total enrollment 138,160 no of trainees and graduated about 131,255. RISDA-Bangladesh has been working with 100s of country renounced industries through MoU and overseas recruiting agencies like Trade MiG for Japan, South Korea, Australia & middle east. Total job Placement up to reporting period about 105,001. There are 47,242 no of graduate are Involve In the micro-enterprise with self-employment as entrepreneur. RISDA Institute of Technology (RIT) Is a flagship and ISO certified Institute of RISDA-Bangladesh which has accredited with BTEB & NSDA for certification.

APPRENTICESHIP BASED SKILLS TRAINING

RISDA-Bangladesh very recent has implemented two projects in apprenticeship skills development project under the technical support by BRAC Skills Development Program and funded by SDC titled -PRISE In Cox`s Bazar district we have Implemented the project and

200 youths were received the following methodological skills training & job placement ever In Cox`s Ukhiya, Bazar Sadar. Moheshkhali upazila. We will consider the apprenticeship modal training courses in relation to micro-enterprise hub and demand from community. But as per our previous experience the following courses are privileged by the market & trainees like.

METHODOLOGY

The methodology of the assignments will be demand driven occupations in abovementioned or any others marketable occupations. The learner's selection & age limit will be 18-35 years un-employed youths and 03 steps will be consider like as follows.

- Learner Enrollment & Engagement
- MCP Selection & Orientation
- Peer Leader Selection & Orientation
- Learner & Parents orientation
- Apprenticeship training (Learner placement)



- Technical Trainer (TT) Selection & orientation
- Theory & soft skills Class
- Follow up & Supervision
- Assessment & Certification
- Job placement

The above-mentioned method will be exercise throughout the following 03 steps like: Pre-Training, During Training & Post Training.

WORKPLACE BASE TRAINING (WBT)

RIT started WBT delivery from August 1st, 2022, and till the date (30th April 2023), RISDA on boarded 71 MSME's, enrolled and conducted need assessment for 1471 workers. Among them, RISDA completed WBT delivery at all 56 MSME's for 1168 workers, completed assessment and provided certificates. As per the agreement, RISDA completed WBT for more than 1120 workers. Beside this. according sector wise to achievement, the leather goods sector produced the highest number of WBT graduates which is 681 including. 367 unskilled and 314 semi-skilled



workers. On the other hand, the light engineering sector completed assessment for 238 workers including 153 semi-skilled and 85 unskilled workers. Similarly, the furniture making sector completed WBT final assessment for 250 workers including 143 semi-skilled and 107 unskilled workers.

Alongside the technical training, RIT ensured

knowledge of Decent work and labor rights to all 1168 workers. Also provide training and demonstration on first aid, fire safety, safe uses of materials and storage, workplace policy and procedure, workplace safety and OSH. RIT also promoted 3R to all 51 workplaces to reduce, reuse and recycle waste to ensure environmental sustainability. Promoting inclusivity and ensuring gender friendly work environment was one of the priorities from RIT WBT team.



WBT MODALITY SKILLS TRAINING CASESTORY

Kalpona tunes her family through gained WBT skills in Furniture Sector

Kalpona Begum is a single mother of four children who was struggling financially after her divorce. Her husband left her 4 years ago and not support her or the kids financially. To survive, she worked as a domestic worker, but her salary was low and it was not enough to meet her family's basic needs. Additionally, she had no specialized skills or qualifications to improve her employment prospects.

Best Door and Furniture is a small SME located in Akrain Savar. RISDA Bangladesh with the



help of Swisscontact committed to deliver **WBT** under **B-SkillFUL** Phase-II Programme for their workers at Best Door and Furniture. After motivated by the RISDA team, they agreed to include women workers in their SME. Knowing the women employment opportunity, a worker informed about Kalpona that she is in vulnerable situation and a working opportunity might change

her life. After getting the proposal of receiving training on furniture making, Kalpona was afraid to receive training and work in furniture sector. The RISDA team convinced her to receive the training as a life-changing opportunity. Finally, despite the societal pressures and stereotypes that suggest furniture making is a job meant only for men, Kalpona decided to take up the training.

The decision was not an easy one, as Kalpona knew that she would face many challenges to cope up in the Best Door and Furniture Environment. She was worried about whether she would be able to learn the skills required for the job, and whether she would adjust with her male colleagues. However, she gets the appointment from Best Door and Furniture and enrolled for receiving WBT.

She was enrolled for receiving WBT under the supervision of MCP Md. Moshiur Rahman. During her long one and half month training period, Kalpona worked hard to acquire the skills she needed to excel in furniture making. The Subject Matter Expert from RISDA made a delivery plan to engage her in the carpentry work. At the very beginning, the MCP taught her how do gluing, putting and sanding work. Later, she learned from manual sanding operation to sanding machine operation, drilling operation, nail gun operation, etc. She was also trained about safety at workplaces, PPE, waste management, machine maintenance, etc.



Despite the challenges she faced during training, Kalpona her continued and remained focused on her work. After watching performance, the owner agreed to pay her 8000/- taka monthly. This, was a significant achievement for Kalpona, who was now able to support her family without pressure. She already planned to admit her two children in RISDA Institutes of Technology (RIT) for Skills Training. She hopes that her best days are

coming.

Finally, Kalpona's hard work, determination, and courage in the face of adversity paid off. Despite the challenges she faced, she refused to give up and continued her job. She made example to many other women that they can work in non-convenient trade beside male as well. Following her, later three more women joined Best Door and Furniture and received WBT. The management of Best Door and Furniture also made separate washroom for them. Other male colleagues are also respecting them now.

4.3 COMMUNITY DEVELOPMENT

EDUCATION

RISDA-Bangladesh has been developed Its mission & Vision to targeting the under privileged, marginalized, and hard to reach peoples. Since the Inception of the organization has Initiated in education programme for dropout school children. RISDA-Bangladesh run 10 informal primary school at Mirpur. This reporting year about 600 Students are learning In those NFPE schools. RISDA believes society can't



change without formal education, especially for 21st century's education demand to skills education & employment. Goal of education programme Is "Education for Engagement and Development". The project supported education program's not the solution of providing the

quality education is also the SDG goal-4.

In this perspectives RISDA-Bangladesh Intake and established a formal technical education Institute **F.K. Polytechnic Institute.** There are 03 faculties in enrollment of student like Civil, Electrical& Computer for 04 years diploma Engineering. along with SSC vocational education. The reporting year student of 04 years diploma course 23(admission is on-going) and up



to date 235 where female Is 35 and SSC vocational course enrollment in this year 55 and cumulative 514.

HEALTH & NUTRITION

The program started since 1998 in Dhaka, the capital city of Bangladesh. The objective of the program is to provide training for the rural /village doctors, raising public awareness about personal health, hygiene, family planning, food & nutrition and supporting Primary Health Care as well.

RISDA-Bangladesh has continued different activities since the inception. COVID-19 along with other activities as part of its social responsibility. We are arranging public awareness



program regarding COVID-19 pandemic. Organizing different volunteer groups and train them to assist helpless people. Organizing special training programs on COVID-19 for village doctors. Free masks and hand sanitizers have been distributed among the people during COVID-19 pandemic. Supplying Oxygen cylinder to the COVID-19 affected patients. Supplying medicines & food items to the COVID-19 affected patients. Arranging ambulance service.



Food has been distributed among day laborer's and helpless people. Disinfectant has been sprayed for cleanliness. Managing primary health care. WOMEN EMPOWERMENT

The Vulnerable Group Development (VGD) program is a prominent social safety net initiative implemented by the Government of Bangladesh, specifically designed to cater to the needs of ultra-poor households. The primary goal of the Program is to enhance the income-generating abilities of VGD women and promote their social empowerment. This is achieved through several means, including training sessions aimed at



raising awareness, providing instruction on a range of Income Generating Activities (IGA), and offering credit services both during and after the term of food assistance. The project in question has been implemented by RISDA-Bangladesh from 2009. During the specified time frame, the organization successfully executed the project in collaboration with 13 Union Parishads across three Upazilas, namely Rangamati Sadar, Naniarchar, and Rajosthali, all located within the Rangamati District. In the reporting period this Vulnerable Women Benefit (VWB) program has operated at Pangsha in Rajbari District and at Kumarkahali in Kustia district.

The total number of VWB cardholders is 2600. The entirety of the members is partitioned into 120 distinct groups, with each group including a range of 25 to 30 members. The primary elements of this program include of life skills training, training in income-generating skills, savings, and access to credit. In order to improve the quality of life and promote self-sufficiency among the women mentioned, a program of social awareness training has been arranged. The training program encompasses various topics related to daily life, including Food and Nutrition, Disaster and Risk Mitigation, HIV/AIDS, Health and Cleanliness, and Women empowerment. The IGA training program encompasses several areas of agricultural and livestock management, such as poultry rearing, kitchen gardening, as well as cow and goat husbandry.

WATER, SANITATION & HYGIENE (WASH)

RISDA-Bangladesh asserts that inadequate water and sanitation infrastructure provide a substantial obstacle to enhancing the health and well-being of individuals, with a clear correlation to nutrition. RISDA acknowledges the significance of healthy water in terms of its nutritional value and its status as a fundamental human right. It is imperative that every individual is granted sufficient access to safe water. In the context of Bangladesh, there exists a significant lack of awareness among the population regarding the importance of utilizing safe water for both drinking and domestic purposes. Additionally, there is a notable lack of knowledge regarding the proper utilization and maintenance of sanitary latrines, particularly in rural regions. Consequently, the population often experiences a range of waterborne and

sanitation-related illnesses, resulting in additional economic and societal burdens. The occurrence of irregularity in schools is a common practice observed among the students.

The field observations conducted by RISDA have indicated that individuals possess the inclination, abilities, and means to engage in the project activities.

However, their participation is sometimes limited as a result of



insufficient awareness. RISDA acknowledges that motivation serves as a crucial instrument for fostering individuals' comprehension of the significance of safe water and sanitation. Subsequently, RISDA initiated an awareness effort targeting the participants of the Microfinance Program group. Additionally, it offered additional credit to members of the group who were involved in the installation of tube wells and the construction of latrines. To date, RISDA-Bangladesh successfully implemented the installation of 210 tube wells and the construction of 6,750 ring slab latrines.

4.4 RENEWABLE ENERGY

SOLAR HOME SYSTEM

Since 2011, RISDA-Bangladesh has been actively engaged in the implementation of the Solar Home System Project. The primary aim of this initiative is to encourage the adoption of renewable solar energy in areas where households do not have access to grid electricity. By providing electrification through solar power, this project contributes to the preservation of a clean energy and environmentally sustainable ecosystem. Additionally, the SHS does neither require a billing payment system nor incur any fuel costs for its operation. In addition, it is noteworthy that a standalone hybrid system (SHS) can be utilized by individuals for a maximum duration of 20 years without experiencing any instances of load-shedding. Over



the course of an extended period, the implementation of lighting solutions not only leads to cost savings but also extends the working hours for individuals residing in rural areas. To ensure access to affordable and modern energy services and reduce the dependency on fossil fuels, RISDA has implemented Solar Home System, Solar irrigation, solar mini-grid projects. RISDA-Bangladesh successfully implemented the installation of 175,000 Home solar System, 1345 solar AC system, 2405 solar DC system, 21 solar Irrigation pump.

SOLAR STREET LIGHT

The utilization of solar energy in conjunction with light-emitting diodes (LEDs) The use of CFL (compact fluorescent lamps) offers a highly efficient alternative. Solar-powered outdoor lighting solutions are highly suitable for illuminating areas in distant locations where access to electricity is either absent or unreliable. Even within metropolitan environments, these technologies are widely utilized to decrease reliance on traditional power sources and make significant contributions to sustainable energy production. The solution's reliability and durability contribute to its effectiveness in meeting both our current and future lighting needs. Since 2015, RISDA-Bangladesh has been implementing the Solar Street Light Project as a solution to address the street lighting issue in rural regions. During the specified reporting period, RISDA-Bangladesh successfully implemented the installation of street lights. As of June 2023, the



total number of street light installations reached 1200.

NATIONAL DOMESTIC BIOGAS



The Domestic Biogas Program was initiated by RISDA in August 2009. The primary aim of the National Domestic Biogas and Manure Program is to alleviate the burden on individuals, particularly women, by reducing their workload. Additionally, the program seeks to enhance health and sanitation conditions, boost agricultural productivity through the utilization of slurry, conserve traditional fuel sources like firewood, agricultural residues, and dried dung cakes, and mitigate greenhouse gas emissions, particularly carbon dioxide and

methane. In addition, RISDA offers technical assistance for the upkeep and repair of the plants. RISDA-Bangladesh successfully completed the construction of 556 sets as of June 23.

IMPROVED COOK STOVE

Since January 2017, RISDA-Bangladesh has been implementing the Improved Cook Stove (ICS) Program with the assistance of IDCOL. The primary goal of this program is to decrease the consumption of cooking fuel and mitigate Indoor Air Pollution (IAP), particularly among women and children. This is achieved by promoting the distribution of more efficient cook-stoves. The project employs a cluster-based method to implement the program in the Madaripur and Shariatpur districts. As of June 2023, the cumulative number of installations are 12,580 sets.



4.5 AGRICULTURE & ENVIRONMENT

rearing etc. Considering environment all RISDA-Bangladesh premises has developed with green garden. Throughout RISDA-Agro there are milk cows rearing and contributed in the country pure milk for ensuring nutritious nation monthly around 6,000-liter and yearly 72,0000 liters of cow milks are produced and marketed. In Muslim festival time there are 100 of bulls (not contaminated food) supplies in market for meat purpose. Yearly 100,000 seedlings are produced in the horticulture nurseries. Those are fruits & wood plants. This Is fast growing sectors in the RISDA-BANGLADESH programme.

4.6 HUMANITARIAN RESPONSE

The program was initiated in 2017 in the Rohingya refugee camp. The primary aim of the program is to offer vital aid to individuals affected by the situation and ensure the safety and well-being of all individuals, irrespective of gender or age. The program has successfully provided various forms of assistance, including shelter, food supplies, non-food items, medical care, NFPE schooling, vocational training, water and sanitation facilities, solar electrification, and tree plantation initiatives. As of June 2023, we have made significant accomplishments. An additional 8,750 adults were provided with vocational skills training, while over 12,000 children received non-formal primary education. Moreover, an increase of 20,000 patients received primary treatment, and an additional 12,000 families received food support. Additionally, 12,000 families were provided with nonfood items support, and sanitation support was extended to the same number of families. The following sectors are covered by the Humanitarian Program like.

- Food & Non-food items distribution
- Healthcare & Nutrition
- Shelter
- Water Supply, Sanitation & Hygiene (WASH) Facilities
- Education in Emergency
- Energy and Environment
- Skill Development Training
- Relief & Rehabilitation

RISDA-Bangladesh is of the opinion that it is our moral obligation to provide assistance to those in need to the greatest extent that we are able. Therefore, RISDA-Bangladesh uses the money it raises via its own contributions to fund a variety of charitable/ relief activities that assist the country's most disadvantaged people. We have provided disadvantaged people with assistance devices, as well as winter clothing and educational materials for underprivileged



children and youth. In addition to this, it distributes meat to those who are in need by carrying out the Qurbani Program in several various project locations. The reporting year about TK 155,500 were expense to the various type of vulnerable peoples where Gulistan Hokker`s market fire damage rehabilitation, Poor people's treatment etc.

4.7 AGENT BANKING

Agent banking is a program aimed at extending doorstep banking services to reach a wider population, particularly those in underserved areas. The platform provides a diverse range of account options. The services offered include cash deposits and withdrawals, payment of foreign remittance, utility bill collection, fund transfer, balance inquiries, acceptance of clearing checks, application for check books and debit and credit cards, as well as internet banking services. In addition to facilitating



the establishment and management of miccas accounts, the local community is offered access to small-scale and agricultural loans. Total client up reporting period no 1,550 and deposit amount tk 39,482,487.00
